1. Executive Summary

Jurisgraph is a technology startup focused on developing AI-powered research tools in taxation fields. It helps tax professionals, lawyers, students, researchers, tax authorities, tax consulting firms, tax institutions ("Tax Players") in speeding up their research works with reliable resources. Our key product, **Jurisgraph**, uses machine learning LLM to analyze questions via chat BOT, checking legal references, optimizing manual research work, reducing manual intervention fatigue and boosting efficiency. We aim to transform the way Tax Players conduct their tax analysis.

Idea: AI-LLM model (cloud-based and on-premise) tool in automating tax analysis and reduce tax research manual work

Mission: to automate reliable real-time tax research work and widen the scope to any research work from legal to government sectors

Vision: to be the first platform in the world in providing reliable chatbot assistance for highly sensitive and confidential projects without manual research analysis

Revenue Model: Subscription, maintenance & ad-hoc deployment

Target Market: at the first stage, tax professionals, lawyers, students, researchers, tax authorities, tax consulting firms, tax institutions ("Tax Players") in the UAE. Subsequently, expanding to various sectors and jurisdictions/markets.

- **Solution:** Pre-mapped the tax materials in one-go, cater tax questions in an efficient way by using AI LLM Chat BOT (cloud and on-premises).

4. Product/Technology

- **Development Stage:** MVP, beta testing: an initial version of the product is available at https://jurisgraph.ai, and it includes part of the UAE legislation on Corporate Tax Law
- Tech Stack: Java (Spring AI with Thymeleaf and HTMX), Neo4J (graph database), agnostic
 with regards to the LLM cloud providers: customers can use their existing subscription to
 OpenAI, Claude, DeepSeek etc

5. Business Model

Pricing strategy

(1) On cloud plan

- A. Tier 0 free with usage limits basically you only pay for your LLM provider but there's a limit on how many requests you can perform on our knowledge base
- B. Tier 1 Bring your own model (the customer decides which provider to use and how much to spend), plus a subscription fee to cover our costs to keep the knowledge base up to date and add more features.
- (2) On premise plan (Enterprise): The customer chooses an open-source model, and we install our knowledge base on the customer premises.
 - Set-up/ installation fee
 - Subscription fee
 - IT maintenance fee (optional)
 - Ad hoc consultation fee (optional) e.g. if the customer wants to integrate their own customer data with our knowledge base

Both types of customers will receive the software and knowledge base updates as part of their subscription.
